






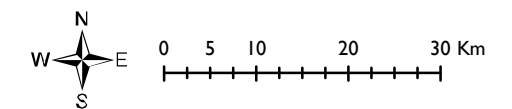
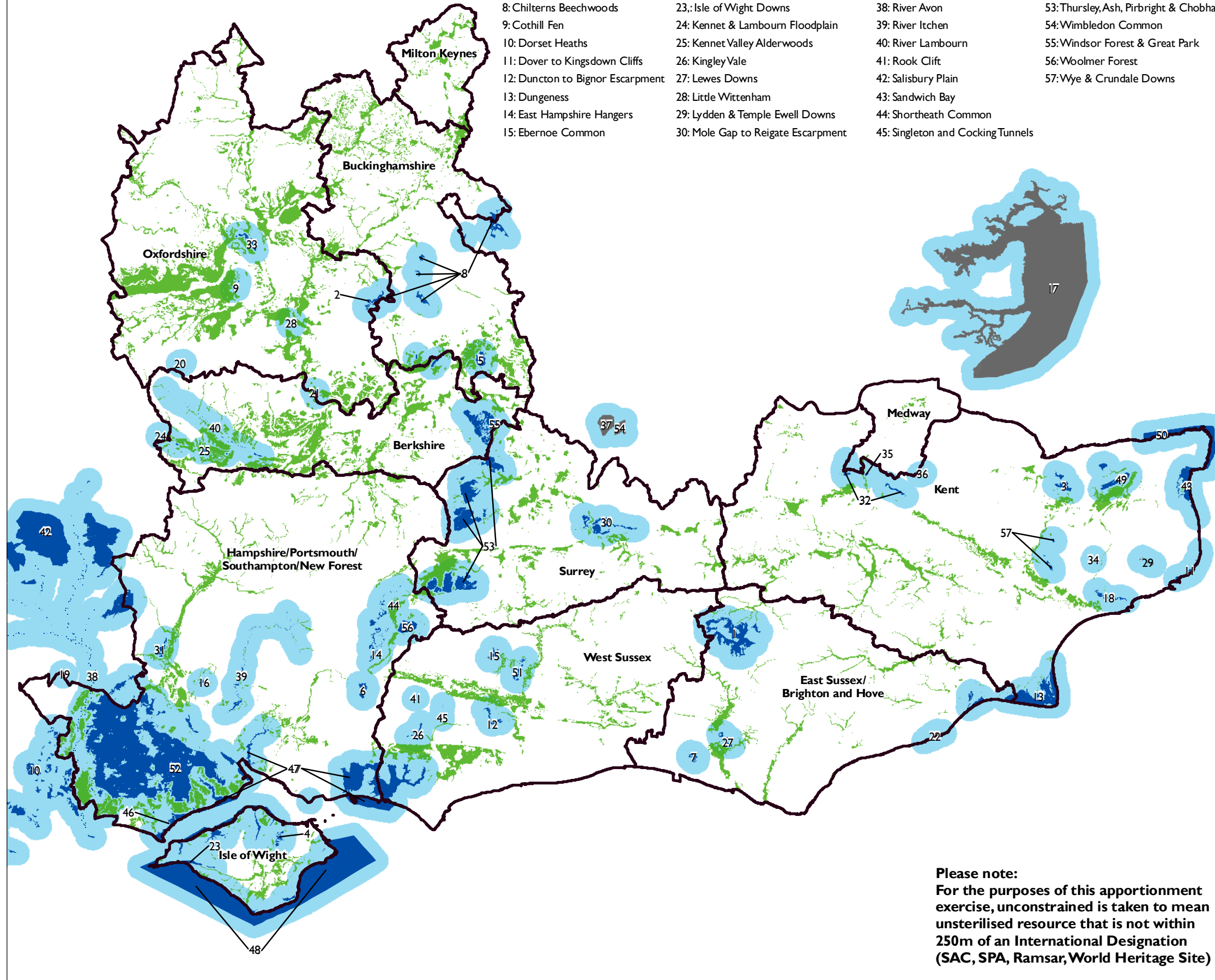
Primary Aggregates Sub-Regional Apportionment in South East England
