

Summary of the Consultation undertaken by Authorities as Part of their Advice to the Assembly.

<p>Hampshire Advice and Isle of Wight Advice</p> <p>The advice submitted by both the Hampshire and Isle of Wight partnerships accepted the figures that were developed as part of the GTAA and the separate consultation that was undertaken as part of this advice.</p> <ul style="list-style-type: none">• The GTAA consultation did include three stakeholder consultation events, February 2006, May 2006 and November 2007.• A 'reality check' exercise was undertaken at the end of the GTAA process, where feedback was obtained from Gypsy and Travellers on local authority sites.
<p>Berkshire Authorities Advice</p> <ul style="list-style-type: none">• A consultation document and questionnaire was sent to 338 external stakeholders, as well as being distributed internally through Berkshire directorates and service groups.• 7 week consultation period during summer 2007.• 82 responses were received; predominantly from Town and Parish Councils (35%), GTTS groups (24%) and statutory/service providers (22%).
<p>Buckinghamshire Advice</p> <ul style="list-style-type: none">• A consultation document and questionnaire was sent to key stakeholders during July and August 2007.• 70 responses were received from a cross section of respondents, including town and parish councils, GTTS community representatives and other organisations including the police and social services.
<p>Oxfordshire Advice</p> <ul style="list-style-type: none">• A consultation was undertaken, primarily to assist with the development of a spatial option B.• Discussion document and questionnaire was sent to key stakeholders during July and August 2007.• 138 responses were received, with most from Town and Parish Councils (64%) and the GTTS community (31%).
<p>Milton Keynes Advice</p> <ul style="list-style-type: none">• A consultation document and questionnaire was sent to 164 key stakeholders during July and August 2007.
<p>West Surrey Advice</p> <ul style="list-style-type: none">• 60 Stakeholders were consulted on Opts A and B during August 2007.

(no further details of the consultation was provided)

North Surrey Advice

- Draft advice and questionnaire circulated to 196 stakeholder groups and individuals.
- 22 replies were received, five of which were from GTTS.

East Surrey Advice

- A consultation exercise was undertaken (*No further details provided*).
- At least 57 responses were received.

West Sussex Advice

- Consultation document and questionnaire was sent to key stakeholders in September 2007.
- A minimum of 37 responses were received.

East Sussex/Brighton and Hove Advice

- A consultation document and questionnaire was sent to 60 local stakeholders.
- Held during a six week period during July and August 2007.
- A specific meeting was also held with key stakeholders groups including the showmen's group. There was also an East Sussex travellers forum held with Gypsy and Travellers and their representatives.

Kent Advice

- Two stakeholder events were held in August and October 2007.
- Both events were held as seminars with questionnaire responses collected:

1st Event: 16 questionnaire responses were collected, 10 from the GTTS community.

2nd Event: 46 people attended, 21 of which were GTTS.
